February Mayor Message

The State of the City address was given at the January 9th City Council meeting. In 2023 the City of Vergas began the steps to move Vergas toward the vision outlined in the city comprehensive plan. The comprehensive plan had 58 strategic actions across components of Land Use, Housing, Transportation, Business & Economic Development, Public Services & Facilities and Parks & Open Spaces. At the one-year mark of the plan; beginning steps and progress was noted in 29 (50%) of the 58 strategic actions.

It would be difficult to touch on every aspect, but wanted to highlight two of the key priorities that were outlined in the plan.

Parking was voiced as a priority in the comprehensive plan. With Vergas securing the lot, where the Otter Tail County garage was located, there are 21 new parking spaces to the downtown. There will be finishing touches of asphalting, parking lines and fencing this spring. Housing was another voiced priority. With new housing developments, there are 51 new housing lots available in city limits; Lawrence Lake 24, Keily Shores 16, and Sunny Oaks 11. OTC will have 3 of the Sunny Oaks lots with a future plan for 6 Senior Living Units.

The Comprehensive plan and established VISION Statement for Vergas have driven a number of actions and accomplishments that aligns Vergas for continued success. A new Utility Billing Program Muni Billing

The City of Vergas has purchased a new utility billing program. You will notice a change in the look of your utility bill. The city would like to invite you to receive your utility bill by email and pay with Automatic Clearing House (ach). If you sign up for both email and ach payments, a credit of \$1.00 will be applied to your bill. The city will be discontinuing our current ach payments through Vergas State Bank, the municipal pay and DOXIO. You are still able to pay your bill at Vergas State Bank, the Vergas Liquor Store, or the Vergas City Office.
