Remodeling Project

Malone presented project to committee. Largest concern is budget and to “work with what we have.” No interior work was specified, if windows are included, the cost will increase the budget. Committee agreed windows were a lower priority. Plans and sample materials were presented to the committee.

Committee asked Malone to plan for updating the exterior with some sort of structure, like a trellis in the front and a possible awning in the back. Malone is to investigate replacement of the side fire doors, he will provide notes in the proposal for door replacement, but not necessarily construction plans. Malone continue discussion outside.

Malone will create new rendition, project list to help solicit bids, and will work on project scope. Committee discussed projects: east sidewalk and middle emergency door. Doors are less of a priority, but the hardware is not up to code.
