#### RESOLUTION ADOPTING LEGAL SPONSORSHIP

THE CITY COUNCIL OF THE CITY OF VERGAS, MINNESOTA DOES HEREBY RESOLVE AS FOLLOWS:

BE IT RESOLVED that the City Council of the City of Vergas, County of Otter Tail, Minnesota, act as legal sponsor or the project contained in the Outdoor Recreation Grant application to be submitted on 28<sup>th</sup> day of March 2022 and that Julie Lammers, City Clerk-Treasurer, is hereby authorized to apply to the Department of Natural Resources for funding of this project on behalf of the City of Vergas.
