# Ordinance Review Burning



*OPEN BURNING.* The burning of any matter if the resultant combustion products are emitted directly to the atmosphere without passing through a stack, duct or chimney, except a recreational fire as defined herein. Mobile cooking devices such as manufactured hibachis, charcoal grills, wood smokers, and propane or natural gas devices are not defined as an open burning.

RECREATIONAL FIRE. A fire set with approved starter fuel no more than three feet in height, contained within the border of a a recreational fire site using dry, clean wood; producing little detectable smoke, odor or soot beyond the property line; conducted with an adult tending the fire at all times; for recreational, ceremonial, food preparation for social purposes; extinguished completely before quitting the occasion; and respecting weather conditions, neighbors, burning bans, and air quality so that nuisance, health or safety hazards will not be created. No more than one recreational fire is allowed on any property at one time.

RECREATIONAL FIRE SITE. An area of no more than a three foot diameter circle (measured from the inside of the fire ring or border); completely surrounded by non-combustible and non-smoke or odor producing material, either of natural rock, cement, brick, tile or blocks or ferrous metal only an which area is depressed below ground, on the ground, or on a raised Included are permanent outdoor wood burning fireplaces. barrels are not a recreation fire site as defined herein. Recreational fire sites shall not be located closer than 25 feet to

## **Construction Permits**



Vergas construction permits can be found online at <a href="https://www.cityofvergas.com">www.cityofvergas.com</a> or stopping by the City Office. Permits get approved the 2<sup>nd</sup> Monday of the month be sure to apply early.

#### A Construction permit is required when:

- ✓ Building or remodeling a house
  - √ Re-roofing and/or re-siding
- ✓ Putting in a shed over 120 squared feet
- ✓ Installing a fireplace, wood stove, or chimney
  - ✓ Finishing your basement
  - √ Adding a garage or any addition
    - √ Replacing windows
- Construction a retaining wall over 4 feet in height
  - ✓ Construction a swimming pool
    - ✓ Putting in a deck or porch
  - ✓ Putting up a fence over 30 inches in height
- ✓ Soffit, fascia, Gutters and trim (weather protective items
  - ✓ All commercial work
- Flectrical work MUST have an electrical permit that must be obtained separately from a Minnesota State Contract Electrical Inspector (218)342-3345 or (218)849-6059.

Without required Certification of Completion the building will not be allowed usage or issued the Certificate of Occupancy.

## A Construction permit is **not** required for:

- ✓ Movable cases, counters, & partitions not over 5 feet 9 inches high
- Platforms, walks, & driveways not over 30 inches above grade & not over a basement or storage below ground
  - ✓ Painting, wallpapering, or paneling
    - ✓ Temporary stage sets & scenery
    - ✓ Sheds under 120 squared feet
  - ✓ Installing carpeting or other flooring

- ✓ Window awnings not projecting more than 54 inches on homes
- Prefabricated above grade swimming pools of a capacity of 5000 gallons or less
- ✓ Redecorating without structural change
  - Replacing cabinets in kitchen or elsewhere
