December Mayors Message

As we enter the close of the year, the Council reviewed and took some beginning steps for funding opportunities into the next year that will maintain and improve the community

The City is applying for a Local Road Improvement Project (LRIP) through Otter Tail County to improve the conditions on West Lake Street. This is a street off Hwy 17 that runs up to the new Lawrence Lake Addition. The road is narrow, with no shoulders, and has steep ditches. It represents a number of safety concerns for those using the road and the increasing traffic.

The City is also making a request to the Minnesota
Legislature to consider a local retail sales tax of 0.5% to
make Long Lake Park improvements. Priority being the
restroom facility. A park improvement plan was
developed in 2023 with a 1.2 million dollar price tag if the
whole plan were executed. The park is important to
Vergas environmentally and economically. Applying a
local sales tax would provide an opportunity of funding
from all who visit Vergas and use our park facilities,
versus relying on local resident funding. Of course, this
would not proceed without a vote from the residents. If
approved by the State Legislature, it would be on the
2026 November election ballot.

Lastly, the City is filing an intent to apply for the Transportation Alternatives Grant that is consistent with the City of Vergas Trail Feasibility Study that was developed in 2023. There were 2 primary trail connections outlined in the plan. The Maplewood park connection was completed with the work on County Road 35 this past summer. The other trail connection is connecting Vergas to Frazee by extension to the Heartland Trail. Filing an intent does not commit Vergas to complete a full application, but it provides time to consider options and receive feedback from MnDot.

Always appreciate thoughts and feedback on the work of the City Council in meeting the needs and vision for Vergas.

(A) The Mayor or other designated official may declare a snow Meeting: emergency in the city. The emergency shall continue in effect for a

period of 24 hours or until the snow has been removed from the city's streets or until the snow emergency has been rescinded by action of the Mayor, Police Chief or other designated officer.

"71.04 DECLARATION OF SNOWEMERCENCY: PARKING PROHETED.

(B) Notice of the declaration of a snow emergency shall be given by notifying the local news media; however, the notification shall be a service aid only and not a duty on the part of the officials.

(C) During a declared snow emergency or enough snow has accumulated to plow, no motor vehicle shall be left parked on any street or public way in the city until the declared emergency is canceled or, if no emergency is declared, until the street is cleared on both sides of accumulated snow

(D) During a declared snow emergency, any city employee, who finds a motor vehicle in violation of this section shall attempt to contact the owner of the motor vehicle and require the owner to immediately move the motor vehicle so as not to be in violation of this section. If the owner does not immediately remove the motor vehicle or the owner cannot be located, the utility maintenance employees are authorized to have the motor vehicle removed at the owner's expense.
