Mayor Message

As fall approaches, you will see a number of improvement projects occurring in Vergas. The Vergas Event Center, Municipal Liquor Store and CDH-Vergas Fire Hall will have building weatherization improvements with the Vergas Event Center ultimately having solar panels installed. The Event Center will additionally have a battery hub that will allow for back up energy needs for the community in the event of power failure. The city will see an estimated

\$2000.00 in annual energy savings with the use of solar. These improvements are supported by the energy grants the city has received. Additionally, the downtown back-alley (alley way behind municipal liquor store); the back-alley parking lot; and the alley connections to main street (on each side of the municipal liquor store) will be asphalted. It will also include repair of a drain to address issues with surface water drainage. Overall, there will be improved alley road conditions, which will allow for better maintenance.

Lastly, Otter Tail County Department of Transportation will be doing etched crosswalks at the downtown intersections. This is a more permanent marking vs the painting of crosswalk lines that had been previously done by the county. The etched crosswalk marks will be more visible and durable. There have been requests for a pedestrian crosswalk in the middle of Main Street. However, with Main St. being a County Hwy; the County prohibits this action.

This is a lot of activity. Though there may be some short-term inconvenience, no major interruptions are anticipated. If you have further questions or concerns, please contact the city office.

Notice is hereby given that the Vergas City Planning Commission will conduct a Public Hearing regarding a variance for the impervious surface at 880E Scarf Ave.

Current Ordinance:

Lakeshore Management Ordinance Section 8 VEGETATION AND LAND ALTERATIONS SUBP. 4. Stormwater Management

- Stormwater Managem

B. Specific Standards

1: Impervious surfaces of lots must not exceed 25 percent of the lot area, of which buildings must not exceed 20% of the lot area.

880 E Sharf has applied to use up to 26 percent of their lot.

All interested parties are invited to attend and will be allowed to ask questions and provide public input and/or comments. If you are unable to participate in the hearing, you are invited to submit your comments in writing to the City Clerk-Treasurer before the scheduled hearing. Written comments and questions will be addressed at the hearing, and the City will provide a written response. Non-English-speaking residents and other individuals with special needs who plan to attend the hearing are asked to contact City Hall at (218) 302-5996, ext. 1, before the hearing so arrangements can be made to address any specific requirements.
