Public Hearing regarding Well Head Protection plan was officiated by Aaron of MN Rural Water.

Motion by Bunkowske, seconded by Stall to accept agenda with the addition of Ole's Ride and Gravel Pit Ordinance set back. Motion passed unanimously.

Motion was made by Goodman, seconded by Smith to approve the minutes of the June 13, 2017 meeting. Motion passed unanimously.

Motion was made by Goodman, seconded by Stall to approve City bills totaling \$40,559.42. Motion passed unanimously.

Motion was made by Goodman, Bunkowske to approve Liquor Store totaling \$59,408.06. Voting yes: Goodman and Stall. Abstain: Smith. Motion passed.

Motion by Stall, seconded by Bunkowske to approve construction permits for 610 Scarf Avenue for patio pavers. Motion passed unanimously.

Colleen Hoffman of Hoffman, Philipp & Knutson, PLLC auditing firm reported to the Council the 2016 Audit. Hoffman stated the Council made a wise financial decision combining the Clerk/Treasurer position with the liquor store manager and stating the department heads (DuFrane and Lammers) do a great job keeping their spending within the budget. We do need to review our water and sewer funds as they are still both in a negative balance. Hoffman stated the fire relief association has not hired an actuary to establish their rate and will need to do so to stay in compliance.

Motion by Goodman, seconded by Stall to approve Lion's Raffle Permit for Jan. 19, 2018. Motion passed unanimously.

Motion by Smith, seconded by Bunkowske to amend motion to include suggestions from Attorney Steve Peloquin. Amendment passed unanimously.
