#### October Mayor's Message

At the September 12th City Council Meeting, the Otter Tail County Ordinance was adopted that regulates the use of cannabis and cannabis derived products in public places. Note this is not just smoking, but also consumption of a cannabis product. There was no opposition to the ordinance at the public hearing held prior to the City Council Meeting. The Planning Commission is responsible for zoning and will be reviewing the retail of cannabis. There will be no state licensing available for retail sales until January 2025.

Cannabis and cannabis derived products CAN NOT be used in public places, which is public park or trail, public street or sidewalk, indoor area used by the general public or places of public accommodation. This would include restaurants, bars, retail businesses, gyms, places licensed to sell liquor, common areas in buildings. A full version of the ordinance is available on the City website.

I had previously noted I would keep the public informed of the condition of City wastewater pipes and the wastewater pond in regard to fats, oils and grease (FOG). The City continues to actively work on this, and it appears to be stable and not getting worse. Thanks for everyone's attention to this, it makes a difference!

A public comment meeting was held on September 27th regarding City purchase of 131 Main Street. Appreciated those in attendance and providing feedback to the council. Unique in this situation was the short-imposed time frame to make an offer, which did not allow for a public comment meeting prior to the City proceeding with a purchase offer. Though this was a unique situation; it was noted during the public comment meeting the importance and desire of citizens to have the opportunity to provide input with major capital purchases. This is also the goal of the Council and the Council strives for good public communication. The Council considered the comments and the previously reviewed information and impacts and voted to proceed with the purchase.

Overall, the building, at 131 Main, allows needed expansion of the Liquor Store and the space to better serve the public and meet City space needs. It presents the most costeffective approach versus new building and remodeling.
